Paying for Your Artwork

All art purchases require payment in full the night of the sale.

Checks are to be made payable to the Frank Phillips Foundation, Inc. Visa, MasterCard, American Express, and Discover cards also are accepted. However, buyers choosing to pay by credit card will incur a fee on their total invoice of three percent (3%). State and local sales tax will be added to the purchase price, when applicable. Any tax exemption will be verified.

Note: All art will remain on display until the close of the exhibition on August 4, 2024, by which time each purchaser must have completed shipping arrangements. Items will be shipped to the buyer according to the agreed- upon arrangements. Buyers of sale pieces are responsible for shipping or picking up their purchased piece.
